How to Submit Testimony:

Note: Testimonies may only be submitted for Bills that have a scheduled hearing date.

Step 1: Visit <https://www.capitol.hawaii.gov/home.aspx>



Step 2: In the upper right hand corner, either click to **Sign In** or **Register** to create your account. If you're creating an account for the first time, you'll immediately receive a confirmation email from "mailinglist@capitol.hawaii.gov". Follow the link in the email to complete setting up your new account.

Step 3: Once you are logged in, **enter the bill number** that you'd like to submit testimony for. The UI bills are: **HB470, SB682, HB1005, SB1159**. Note: You can submit on all four hearings or pick one to submit on.



Step 4: After entering the bill number and clicking Go, you are brought to the **bill home page**. In this example we are using Bill HB470.
