# Introducing the **ProService COVID Navigator**

Employee health screenings are a critical part of minimizing the spread of COVID-19 and operating safely in Hawaii. Introducing the ProService COVID-19 Navigator powered by iHealthHome and MediKeeper. It's a new tool that makes it easy for employers and employees to incorporate COVID screening into their daily routine with an automated screening process.

## How It Works For Employees:

### **Employees download the app** on their phone or mobile device and create an account to get started. If they don't have a mobile phone, they can create an account online.

- Daily notifications on the mobile app remind employees to complete their screening.
- To complete their screening, employees answer a **brief questionnaire** about their health based on the latest CDC guidelines.
- Employees sign their questionnaire to verify that they have completed the screening process.
- Upon completion, employees will receive a "Clear for Work" or "Not Cleared for Work" badge with a date stamp based on their answers.

# How It Works For Employer Administrators:

- The majority of employees will generate a "Cleared for Work" status when they take their daily COVID screenings on their mobile device from home.
- If an employee is "Not Cleared for Work", administrators will immediately receive an email or text notification prompting them to login to the
- Once logged, administrators can plan their follow-up with at-risk employees and log their actions with case management notes that automatically create documentation.
- Administrators can easily **run reports** to see status and case notes by employee. Or ask employees to display their badge upon entering the worksite.
- The administrator portal will include quick links to ProService's top COVID-related resources.



## Readiness Checklist: Requirements for Success

- ☐ All employees need a work or personal email address to login to the mobile app.
- ☐ A smart device to use the mobile app OR access to a computer with internet is necessary to complete the health screening online if an employee doesn't have a mobile phone. Note: The app is most compatible with iPhones iOS12 or later and/or Android 6 or later.
- ☐ Employees should have access to a thermometer at home in order to log their temperature daily. Note: Consider asking employees to purchase an affordable thermometer. Alternatively, employers can offer to purchase them for their team. Similar to investing in a face mask, monitoring temperature with a thermometer is an important step in helping everyone stay safe.
- ☐ Employer administrators designated to follow-up with symptomatic or exposed employees should have a willingness to learn how to monitor employees and run reports in the web-based administrator platform. Note: ProService will be unable to login to client's administrator portals to run reports, read case notes etc.
